DECLARATIONS OF CONDITIONS

- > The Registration period runs from 1 November to 31 October each year. The expiry date of this registration is shown on the first page of the application form and can also be found on your animal's registration tag.
- Dogs 3mths and over must be registered at all times.
- Cats 6mths and over **must** be sterilsed, micro chipped and registered. A penalty of \$200 may apply. Proof of sterilisation is required. Micro chipping number is required with the application and will be added to the Shire's database.
- Council must be informed immediately of any change in ownership, the death of the animal and any change of address IN WRITING
- > Proof of sterilisation is needed to claim the concession rate. EG Sterilisation certificate
- > A copy of current Pension Card is to be attached each time the Pension Concession is claimed.
- At all times the animal must wear a current registration tag, together with a tag bearing the owner's name and current address. This will help Rangers reunite you with your animal should it become lost.
- Registrations are transferrable between local government councils, both the current and new local government council must be notified of the change.
- > Duly authorised agents must have written authorisation from the owner prior to acting on their behalf.
- > The registration is valid unless cancelled pursuant to section 16 of The Dog Act 1976.
