RAV NETWORK ACCESS – **SHIRE STAFF** RESEARCH **PROJECT UPDATE**

Further to the recent request for nominations of Shire roads that transport farmers operators or would like to see added to or enhanced within the RAV network, the Shire has received several road nominations that have been suggested would lead to improvements to the local freight grain transport tasks.

In recording its thanks for these nominations, and to inform and assist Council with its future RAV network deliberations, the Shire will now ligise with Main Roads Heavu Vehicle Services (HVS) with a view to having the roads assessed to

determine if the roads are safe and suitable for RAV access.

It is envisaged that a further project update will be provided in March/April 2023.
