

#### Background:

The Strategic Resourcing Plan forms a component of the Plan for the Future as required by section 5.56 of the *Local Government Act 1995*.

#### Comment:

The purpose of the plan is to reflect and provide financial future guidance after considering the currently known requirements, such as asset acquisitions, renewals and disposals. The Capital programs are base off the current 5 to 10-year programs already in place with the budget, and forecasts anticipated operating income, expenditure and grants.

Being a 2019/20 audit issue, and like all budgetary processes, this plan is a living document and can be changed as circumstances require. It also provides a starting point for development of forthcoming annual budgets and an important element in calculating the Shire's statutory ratios under the integrated planning and reporting framework.
