### **Background**

The Shire's Audit Committee established under Part 7 of the *Local Government Act 1995* provides a critical oversight and capacity building function for the organisation.

### **Comment**

The functions of the Audit, Risk and Governance Committee are defined in Regulation 16 of the *Local Government (Audit Regulations) 1996*. These functions include to guide and assist the local government carrying out its financial management functions related to audits.

In the interim audit, the below finding was identified;

### **Finding**

*We noted that the Shire does not have an audit committee charter or terms of reference.*

### **Rating: Moderate**

#### **Implication:**

*Without an appropriate terms of reference, the roles and responsibilities of the audit committee are not clearly outlined, which could affect the effectiveness of the audit committee.*

#### **Recommendation:**

*We recommend that management develop an appropriate audit committee terms of reference.*

*The Western Australian Public Sector Audit Committees – Better Practice Guide (developed by the Office of the Auditor General) contains an example audit committee charter, designed to assist accountable authorities and audit committees develop an audit committee charter that reflects better practice principles.*

The original terms of reference for the committee was adopted in April 2006 and management committed to update the document.

A Terms of Reference has been drafted for consideration.





Whilst it appears from the application that the applicant is seeking access to the CBH's Koorda grain handling facility, the Shire's Works Supervisor, has expressed concerns at the potential for an increased road maintenance impact the extra 20 tonnes mass RAV 7 allows would have on the road surface and a lack of turning or 'swept path' space at the Railway and Haig Streets intersection.

Whilst Main Roads is the approving authority, and Shire staff are aware of the impending transport demand from the 2021 harvest season, it is the staff position and recommendation that Council advise HVS that it objects to the application to amend the RAV rating for the Cadoux-Koorda Road and Railway Street due to the increased road maintenance impact the extra 20 tonnes mass RAV 7 allows would have on the road surface and a lack of turning or 'swept path' space at the Railway and Haig Streets intersection.

However, it may be possible for application to be considered for a Restricted Local Access Permit (RLAP). This permit is for individual access to a road with a specific combination and with suitable conditions to mitigate any risk.

In this regard, and should Council agree, it is suggested that the Shire's Works Supervisor (through the CEO) liaise with Heavy Vehicle Services regarding the provision of a Restricted Local Access Permit (RLAP) in this instance.
