2022/2023 RATES

With the 2022/2023 rates season approaching, please see below information from Landgate regarding changes to the UV (Rural) Revaluations.

KOORDA RURAL UNIMPROVED VALUES - UNDERSTANDING THE CHANGES

Landgate is responsible for valuing all land in Western Australia for rating and taxing purposes in accordance with the Valuation of Land Act 1978. For land outside the metropolitan area and gazetted townsites, land is valued annually on an unimproved basis taking into account the property market activity, and characteristics of the property including broad soil types.

Each year, valuers from Landgate undertake extensive market research including analysing property sales of agricultural land to determine Rural Unimproved Values. Whilst undertaking sales analysis over recent years, it became apparent that our soil classification database limited the accuracy and reliability of our Rural Unimproved Values. The classification of soils into arable (clay, loam and sand types), nonproductive (bush, salt, rock etc) and grazing areas is a key component of how unimproved values are calculated for rural properties.

Extensive research was undertaken including sales inspection and analysis, site inspections, and utilisation of various resources to attempt to rectify the issues and improve the accuracy of values supplied to the Shire of Koorda.

The landsystem information from the Department of Primary Industries and Regional Development was utilised as a basis for reclassifying and recording the soils in Koorda. The data also captured vegetated areas and areas affected by salt or likely to become salt affected. The result of using this data as a base for our soil classifications used to calculate Unimproved Values has seen a marked increase in the recording of non-productive areas (bush and salt) as well as a more consistent approach to the classification of arable and grazing areas.

The impact of this change is varied. Some landowners may see little change in their Unimproved Values, while others whose property was previously incorrectly graded may see reasonably significant changes either up or down. We have reviewed and analysed the data to make the transition to the revised soil classifications as smooth as possible.

2022/2023 RATES CONT..

KOORDA RURAL UNIMPROVED VALUES – UNDERSTANDING THE CHANGES

The broadacre rural market has seen strong growth in recent years due to a variety of factors – favourable finance lending, strong commodity prices, and relatively good seasons. Sales post date of valuation, indicate continued strong growth in market value. We will continue to closely monitor the rural market and assess the accuracy and reliability of the unimproved values we supply.

The reliability of Landgate records enables more accurate and reliable unimproved values which equates to a fair and equitable rating system.

COVID-19

WA has now moved to 'baseline' settings of public health and social measures to control the spread of COVID-19 in the community. In practical terms, this means:

Masks are only **required** for people aged 12 years and older in the following settings:

- Hospitals and health care settings
- Aged care facilities, residential care facilities including disability service facilities and mental health residential facilities
- Public and passenger transport, including taxis and rideshare vehicles, tour buses and school buses
- Correctional facilities

In addition, masks are strongly encouraged where physical distancing is not possible. People may choose to continue wearing a mask in public and work settings for a number of reasons including:

- Masks reduce the chance of getting COVID
- Masks reduce the chance of spreading COVID infected people may be asymptomatic and not know they are infected
- Wearing a mask protects others, including those at risk of severe COVID including people with disability, chronic illnesses and suppressed immune systems
- The risk of COVID transmission is greatest when indoors for prolonged periods without adequate airflow.

People are encouraged to:

- Practise good personal hygiene wash hands often with soap and water, or hand sanitiser, cover coughs and sneezes with a tissue or your elbow
- Practise physical distancing keep at least 1.5 metres or two arms lengths from each other
- Stay home if unwell.

If you return a positive RAT, you are still required to register it with the Department of Health.

Positive cases must still isolate for seven days.

Symptomatic close contacts need to isolate until symptoms are resolved.

Asymptomatic close contacts do not have to isolate for seven days, but must take a RAT each day they leave isolation, wear a mask outside the home, and avoid high-risk settings.
